Winter weather in central Illinois--one of the most unpredictable things in life! While we know we will have very cold temperatures, predictions on precipitation are rarely if ever guaranteed. Terms like the Bloomington Bubble are becoming commonplace.

But what are CCA's procedures should we actually get snow or ice to the point that school needs to be cancelled? What about ball games and practices should classes be cancelled?

School cancellations will be made by 6:30 am at the latest. Depending on the weather situation, the announcement may come out the night before. Due to having more resources to make the call, CCA normally follows Unit 5 decisions. But that decision is not an automatic one; so please always watch for CCA to be specifically mentioned on cancellation sites.

Should it be determined to cancel, the announcement will be posted on both WJBC and Cities 92.9 (radio) and WMBD (television-typically slower to list Bloomington/Normal schools). The CCA Office will also notify all families and staff via email utilizing the email addresses you have listed in RenWeb. This would be a good time for each family to check and update the email address you have listed in your RenWeb profile. On inclement weather days, it is also wise to check your spam or junk folders--group emails often get lost in those folders. Notifications will also be posted on the CCA Facebook Page.

Bloomington/Normal is also very good about getting streets cleared once the snow stops. Often the reason to cancel school is no longer an issue for ball games and practices. Details for ball games and practices will be stated in the initial cancellation email if known at that time. Any further changes or updates will then be handled and communicated from the coach or AD.
